

London Youth Justice Newsletter – December Issue

Dear colleagues,

I'm taking this opportunity to introduce myself to those of you who haven't already come across me in my day job as DCS in Lewisham or through my role as youth justice policy lead for ALDCS. It's also a chance to share thinking in relation to Youth Justice from the national Association of Directors of Children's Services (ADCS) and to consider what this means for us in London.

This time last year ADCS published its [youth justice policy paper](#).

London colleagues made a significant contribution to the development of the ADCS policy and this subsequently informed the Independent Review of Children's Social Care's recommendations on youth justice. Directors of children's services are accountable for the well-being of all children, including children who find themselves in the youth justice system. In line with the Taylor Report in 2016, the ADCS policy and Care Review recommendations recognise that separate systems (government departments, inspectorates, assessment frameworks) for children in the YJS are largely unhelpful. This separation can cause us to lose focus on these children's status as children: their rights and our responsibilities towards them.

In common with the national approach, in London we want to see children in the YJS as children and promote Child First responses. This means shaping services that are better integrated with those for other adolescents, in a way which breaks down silos and reduces the marginalisation and stigma which are often experienced by children in the YJS.

We know we have significant challenges in London, with acute concerns about exploitation and violence, higher numbers of children in custody than any other region, and we incarcerate a disproportionate number of black and mixed heritage boys. While we continue to tackle these big challenges through the work of our youth justice services, we also need to site this within our wider adolescent safeguarding approach which seeks to build safety for all of London's children and young people.

I look forward to taking on these challenges with you and moving us closer to a youth justice system that works for children.

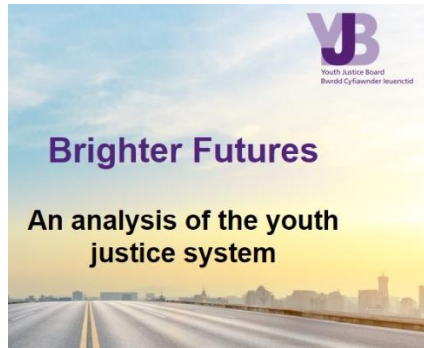
