ADULTIFICATION TRAINING



The London Accommodation and Resettlement Pathfinders (LARP) are working in partnership with Listen Up Research to commission adultification training for Youth Justice organisations across London for senior leaders, frontline staff and operational managers.

We recognise that the adultification of children, particularly young black males, within the youth justice system can lead to a variety of negative outcomes and inequalities.

We are inviting all **senior leaders** within local authorities and the children and young people's secure estate to attend a 90 minute webinar on either **22nd** or **23rd February 10:00-11:30**.

The objectives of this session are:

- Improving senior leaders' knowledge of the concept of adultification.
- To enhance confidence in how to embed the concept of adultification into strategic planning and practice.
- Improve senior leaders' understanding of the broad concepts of intersectionality and adultification and the implications of the systemic challenges on outcomes.

Objectives of the in person training workshops are as follows:

- Understand notions of vulnerability and childhood and how these are applied to some children more than others.
- Understand the broad concepts of intersectionality and adultification.
- Identify ways to guard against adultification in practice.
- Reviewing findings from serious case reviews relating to child criminal exploitation.
