Dear London Youth Justice Leaders

In the December YJ newsletter Pinaki Ghoshal, our ALDCS YJ Policy Lead, said one of the ALDCS ambitions was to find ways to more effectively integrate YJ services with other adolescent services. The challenge can be summed up as that of working through two systems with their own sets of practices, processes and cultures, but with the same children. This is a challenge to which we will have to keep returning, with shared conviction and ambition, but it is one which is given great momentum by the Child First approach (John Drew was eloquent on this point at last week's YJSL Child First event).



Reflecting on that ambition and drawing on the discussions last week, has encouraged us to think about the benefits of bringing our youth justice network and its activities closer to that of the ALDCS adolescent safeguarding programme.

One practical thing we can do to model the integration we want to see, is by communicating through one vehicle. For that reason, in future these newsletters will be for *London Adolescent Safeguarding and Youth Justice Leaders*. There is already a significant overlap in audience and areas of interest, so it is hoped that this will optimise the benefits for all and support a Child First response to children in the youth justice system and beyond.

IMPORTANT UPDATE: URGENT NOTIFICATION RE COOKHAM WOOD

The LIIA Team has been made aware of an <u>Urgent Notification letter from</u> <u>HMIP</u> HMYOI Cookham Wood following unannounced inspection between 4-20 April 2023.

In the letter, HMIP notes that the inspection is the sixth time they have inspected Cookham Wood since 2016 and that these inspections 'chronicle a steady decline in outcomes across all four of our healthy prison tests'.

ALDCS is considering the appropriate response in order to ensure the safety of children placed in Cookham Wood.

At our Child First event, Neal Hazel noted the YJB's intentions to focus on influence beyond YOS's (courts, police, education). Meanwhile, John Drew reflected upon the omission of a focus on the deplorable experience of children in the youth custodial estate or on any commitment to move towards a holistic assessment framework which aligns with wider children's services.

CUSTODY NUMBERS

At the end of February there were **466 children in custody** in England and Wales. This is a rise of 52 on the same month last year and the biggest increase in a number of years. We will need to watch closely to see if this is an ongoing upward trend. **125 of these children were from London** (including a few recently turned 18).


