YJ ANNUAL STATISTICS



Russell Webster's review of the YJB annual statistics makes interesting reading. Numbers of children in custody and those entering the YJ system for the first time continue to fall, as do re-offending rates (but see Danny Shaw's article below for major caveats around re-offending stats). There is also some progress being made on racial disparities. The use of remand in custody and the impact of court delays continue to be major issues.
