Dear colleagues,

As always there is much going on in the adolescent safeguarding / youth justice space in London, much of which is captured in this busy edition of the newsletter. The London Adolescent Safeguarding Oversight Board (LASOB) continues to be an important forum for partners to come together to align our adolescent safeguarding ambitions and initiatives. You'll see below the output of our most recent LASOB and our plans for the coming year.

As I write, the HMI Prisons inspection report on <u>Wetherby YOI</u> has just been published. The concerns expressed by Chief Inspector Charlie Taylor reinforce the importance of the work we are doing in London on safeguarding children in custody. As part of this work, we are keen for Heads of Youth Justice Services to join key Youth Custody Service colleagues for a London roundtable event on 30th April (invites to follow). All colleagues on the ASYJ mailing list will also be invited to an event to promote the Reducing Criminalisation of Children in Care Protocol which we will be holding online on 17th April (see below).

THE LONDON ACCOMMODATION PATHFINDER UPDATE

The London Accommodation Pathfinder (LAP) has been open for 6 months and is now seeing the first of its children transition from the LAP home back to their parents or on to supported or independent accommodation. We have seen numbers accessing the LAP steadily increase and with this we have been able to broaden the offer over recent weeks with both Wipers and Street Doctors commencing their programmes with the children.

In February, we had confirmation that the LAP project funding via the YJB will be extended until April 2026. This funding also includes capacity to develop LAP provision for the South and West London sub-regions. This is excellent news and means that this offer to provide comprehensive, therapeutic support to children in the community, as an alternative to custody, will be available to all London children. ONLINE SESSION ON REDUCING THE CRIMINALISATION OF LOOKED AFTER CHILDREN - 17 APRIL

ER eriminal justice system is well-

The problem of the over-representation of children in care in the criminal justice system is welldocumented and longstanding. In response to this, the <u>Reducing Criminalisation of Looked after</u> <u>children and Care Leavers protocol</u> was developed by MOPAC and partners and was published in March 2021. The protocol outlines the roles and responsibilities of agencies involved in the care of looked-after children and care leavers in reducing unnecessary criminalisation.

To share best practice in how London partners are reducing the criminalisation of children in care, LIIA will be facilitating an online session on 17 April from 2:00 to 3:30 pm. This will hear both national and London perspectives on how to pursue this to achieve better outcomes for children in care. IMPLEMENTING CHANGES TO WORKING TOGETHER TO SAFEGUARD CHILDREN

The Department for Education's statutory guidance, Working Together to Safeguard Children, has been updated and replaces the 2018 version. The linked presentation outlines the changes to Working Together 2023, what the changes will mean and what support can be accessed. The revised Working Together has implications for multi-agency safeguarding arrangements and on safeguarding children from extra-familial harm.

THE STATE OF YOUTH JUSTICE - 2022/23

In January, the Youth Justice Board's publication of the <u>annual youth justice statistics (for</u> <u>2022/23)</u> highlighted positive developments as well as areas of concern.

The Youth Justice Statistics considers the data for the youth justice system in England and Wales for the year ending March 2023. It looks at the number of children (those aged 10 to 17) in the youth justice system, their demographics, offences, outcomes and trends over time.

- Lowest number of children in custody on record
- Rises in children being stopped and searched.
- Increases in the number of children being arrested



Custody numbers for December 2023

At the end of 2023 there were **397** children in custody in England and Wales, compared to **436** in December 2022 (Youth Custody Service, 2023, Table 1.1).

119 children and young people from London were in youth secure estates (including some 18 year olds) in December 2023. This compares to **106** at the same time the year before but accounts should be taken for the fact that there are a greater number of 18 year olds retained in the youth estate (Youth Custody Service, 2023, Table 1.10).



LAUNCH OF THE PAN-LONDON CARE LEAVERS COMPACT

On Tuesday 5 February, the Pan-London Care Leavers Compact was launched. The Compact is a city-wide support offer for care-experienced Londoners, developed by the London Innovation & Improvement Alliance (LIIA) who work on behalf of Association of London Borough Directors of Children's Services (ALDCS), alongside Partnership for Young London, who host the London Children in Care Council.

- Local authority housing support
- Training and employment opportunities in healthcare



The Pan London Care Leavers Compact

The launch event, attended by DCSs, local authority colleagues, elected representatives, partners and care-experienced young people, featured engaging table and panel discussions, highlighting the importance of pan-London collaboration.

The offer provides free prescriptions, discounted travel and a range of housing support for careexperienced Londoners.


