### **Welcome and matters arising – Ben Byrne**

Mary Jarrett introduced as the new Strategic Education Leader representative (SELL) for LASOB, replacing Annabel Bates. She joins as Corporate Director for Education, Waltham Forest.

Jo Clark (Met Police, Operation Aegis), who is presenting on the missing children item.

Previous minutes agreed as accurate.

### **Girls and Young Women Affected by Gangs, Violence and Exploitation - MOPAC, with Social Finance, Abianda, Agenda Alliance**

- Mayor’s priority since 2016; recent research highlights gaps in understanding and support for girls affected by group-based offending and exploitation.
- Girls often experience harm through relationships, sexual violence, and coercion, yet remain underrepresented in policy and practice.
- Multi-strand approach: improving gendered risk assessments, data analysis, and commissioning.
- Launch of **Girls & Young Women Local Groups Fund** to strengthen grassroots responses.
- £610k total; grants of £25k–£80k for one-year delivery.
- Supports safe spaces, peer-led sessions, trauma-informed co-production, and capacity building.
- Applications open 2 Jan – 6 Feb 2026; decisions by mid-March.

### **Building Shared Understanding and Approaches to Missing Children - Paul Olaitan, AKANI Collaborative Solutions and Jo Clarke, Met Police**

Paul introduced the “Who Works!” methodology and presented slides on improving responses to children missing from care homes through Collaborative Knowledge Networks.

Jo contributed insights from the Met Police perspective, reinforcing HMIC findings and the need for consistent application of the Philomena Protocol.

Key points:

- The problem: Children still go missing too often; reports are overused or underused; Philomena Protocol inconsistently applied; care homes, police, and LAs often work from different assumptions.
- HMIC findings: Two causes for concern (Missing & Exploitation); need better risk assessment and partnership working.
- Challenges: Over-reporting driven by fear of blame; fragmented leadership; unclear strategy; misaligned structures; practitioners carrying emotional and procedural burdens.
- Emerging commitments: Clarity on what “missing” means; consistency in tools (grab packs, RHIs); curiosity and connection across agencies; local Philomena compacts; trauma-informed training.
- Next steps: Support BCU-level compacts; align commissioning and inspection; develop shared training and reflection spaces; extend work to other boroughs.

### **Prevent update, working with Children with a violence fixation – Karla Goodman, Lia and Jane Corrigan, Detective Superintendent, Met Police**

- Post-Southport murders, referrals of children with fascination with extreme violence or mass-casualty attacks have increased, often without clear ideology.
- HMIC thematic inspection on counter-terrorism safeguarding scheduled for December.

Key points:

- Individuals with this fascination are appropriate for Channel (per Lord Anderson review).
- Stronger connectivity needed between Channel panels and MACE; escalation routes clarified in new protocol.
- New MACE protocol (live Jan 2026) includes explicit link to Channel and STROTH processes.
- The Met now uses the term “fascination with extreme violence or mass-casualty attacks” as the preferred terminology.

### **Child Sexual Exploitation (CSE) – Bas Dickson Leach, Detective Superintendent, Met Police**

- Following the Casey Review and Home Office commissioned review, significant concerns remain about historic and current responses to group-based CSA/CSE.
- Operation Beaconport is now public and represents a major national undertaking to review cases where multiple victims and suspects were involved but no action was taken.

#### Scope:

- Home Office review (early 2025) identified 1,300 cases nationally for audit; Met contributed 197 cases.
- Met has identified 9,000 cases potentially in scope; initial audit underway to confirm which meet criteria.
- Cases will undergo full case audits to identify missed investigative opportunities.

#### Timelines:

- No substantive case outcomes expected before April 2026.

#### Data Insights:

- Early analysis shows discrepancies between crime data and local authority assessments.
- Victim-led principle emphasised - many victims decline re-engagement, but those who want to reopen cases will be prioritised.
- The term “grooming gangs” is misleading - cases span multiple abuse models.

#### Next Steps:

- Clean and share borough-level data with ALDCS.
